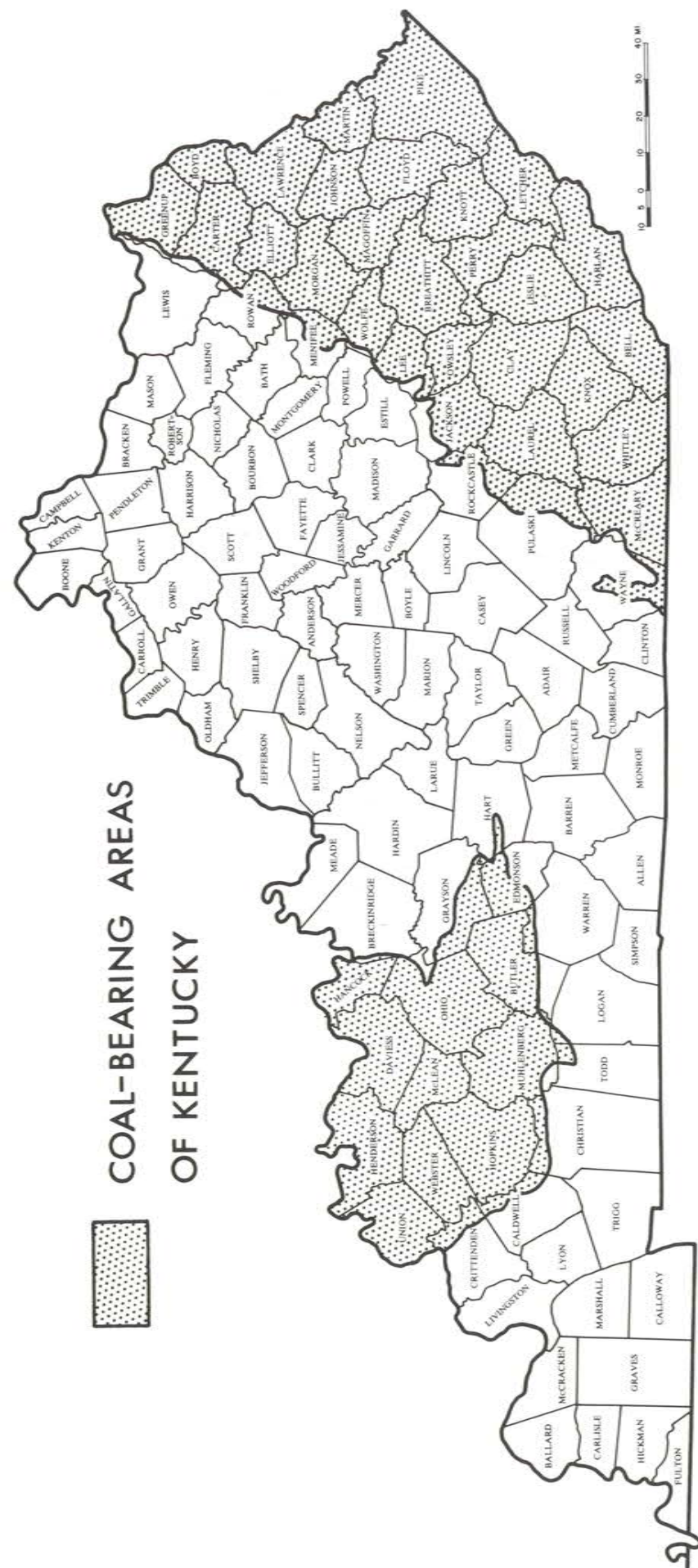

PREFACE

Kentucky ranks second in the United States in the production of bituminous coal. In 1969, the value of coal produced in Kentucky amounted to approximately \$450 million, which accounted for 76 percent of the State's total value of mineral production. Recognizing the need for a compilation of all of the references pertaining to coal in the State, the Kentucky Geological Survey authorized the American Geological Institute to prepare this bibliography. All of the bibliographic citations have been placed in the Geological Reference File (GEO.REF), a computerized, indexed reference file funded by the National Science Foundation.

Two indexes have been included with the bibliography to aid in finding references: one is a subject index; the other, a county index. The subject index contains one first-order heading, Kentucky Coal; second-order headings are shown in italics, and third-order headings are in roman type. The last item in each bibliographic citation is a unique accession number that consists of K70 followed by five numerals. These numbers, along with authors' names, are used in the indexes to identify references in the bibliography.

An attempt has been made to include all existing articles and reports that have been published on the subject of coal in Kentucky. Users of this publication are requested to inform the Survey of any omissions or errors which come to their attention so that corrections can be made in future bibliographic compilations.
